What data do we collect?

La Houppette Ltd. collects the following data:

- personal identification information (name, email address, phone number, etc.),
- copy of I.D card for verification of the registration form,
- photo of student receiving certificate,
- copy of certificate,
- photos of students during their practice.

How do we collect your data?

You directly provide La Houppette Ltd. the majority of your data. This is collected when you:

- register for one of our courses,
- voluntarily complete a customer survey or provide feedback on any of our courses,
- La Houppette Ltd. may also receive your data indirectly when photos are during the lessons.

How will we use your data?

La Houppette Ltd. collects your data so that we can:

- process your enrolment to a course programme and create a file dedicated for your assessments and remarks throughout your learning process,
- email you with information about new or associated course programmes that we think you might be interested in.

If you agree, La Houppette Ltd. will share your data with our stakeholders (other nail product distributors and nail technicians) so that they may let you know about vacancies or product offers. Such stakeholders include:

How do we store your data?

La Houppette Ltd. will keep your demographic information for a maximum of forty years. Once this time period has expired, we will delete your data by shredding the hard copies and deleting the files on the computer.

What are your data protection rights?

The right to access – You have the right to request La Houppette Ltd. for copies of your personal data. We may charge you a small fee of five euro for this service.

The right to rectification - You have the right to request that La Houppette Ltd. correct any information you believe is inaccurate. You also have the right to request La Houppette Ltd. to complete information that you believe is incomplete.

The right to erasure – You have the right to request that La Houppette Ltd. erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that La Houppette Ltd. restrict the processing of your personal data under certain conditions.

The right to object to processing – You have the right to object to La Houppette Ltd. processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that La Houppette Ltd. transfer the data that we have collected to another organization, or directly to you, under certain conditions.
